The Kentucky Board of Examiners of Psychology ("Board"), having met on January 4, 2010, considered the record in the above-styled administrative action, as defined by KRS 13B.130, and the Recommended Order of Default ("Recommended Order") dated November 20, 2009, from its Hearing Officer, and the Board being otherwise sufficiently advised;

The Board noted no Exceptions were filed with the Board by the Respondent to the Recommended Order.

It is hereby ordered the Hearing Officer's Recommended Order dated November 20, 2009, is adopted in full as the Board's Final Order, pursuant to KRS 13B.120, the Respondent being in default, the allegations contained in the Board's Re-Notice of Administrating Hearing and Show Cause Order filed October 6, 2009, are true, and the Respondent committed the violations charged for having been convicted of a felony. The license of the Respondent, No. 0570, to practice psychology as a Psychological Associate is permanently **REVOKED**. The Respondent shall not apply for its reinstatement nor shall the Respondent apply for any other credential from the Board.


The Respondent may appeal this Final Order of the Board to the Franklin Circuit Court within thirty (30) days of the effective date of this Final Order.


