Please see the list below of new and amended regulations. These changes are expected to go into effect late July/early August. Please note, these changes and timing are result of Board actions and not the Department of Professional Licensing. Major changes have been highlighted below; however, updated regulations will not be available for review until early September. Please continue to check the Legislative Review Committee's website for updated regulations under Chapter 26: http://www.lrc.ky.gov/kar/TITLE201.HTM. Along with the regulations, most of the Board's forms have been amended. 201 KAR 26:155 – Licensed Psychologist: Application Procedures and Temporary License Section 2: Temporary licenses will now be issued for one year, with the ability to request an extension for an additional year by completing the Request for Extension of Temporary Licensure as a Psychologist form.

201 KAR 26:160 – Fee Schedule

Section 2: Submitting a renewal during the three-month grace period will now incur a \$75 late fee.

Section 3: Reinstating a license will have a \$100 fee.

Section 4: Registering as a nonresident psychologist will now require a \$100 fee.

Section 7: All fees are now nonrefundable.

201 KAR 26:165 - Inactive Status

Section 1: To request not practicing or inactive status, you will now need to submit the Request for Change of License Status form. To return to active from not practicing status, the same form will be required. To return to active from inactive status, you will need to renew.

201 KAR 26:171 – Requirements for Supervision

Section 1: To change supervisors and/or the frequency of supervision, you will need to submit the Request for Change of Supervisor and/or Frequency form.

- **201 KAR 26:175** Continuing Education
 - Section 3: All continuing education hours needed for renewal must now be completed prior to your renewal date.
 - Removed from Section 5(1): Continuing education programs from the Kentucky Mental Health Institute of the Kentucky School of Alcohol and Other Drug Studies sponsored by the Kentucky Department for Behavioral Health, Developmental and Intellectual Disabilities will no longer be automatically accepted toward the requirement for renewal. They must apply and follow the procedure in Section 5(3).
 - Section 5(1): The list of all automatically approved sponsoring organizations can now be found here.
 - Section 5(2)(d): A workshop in psychology or psychiatry offered by a national, regional, or state accredited academic institution's medical center or affiliated hospital must now submit a completed Continuing Education Sponsorship Application to be accepted for credit. However, the fee is waived.
 - Section 9: The board will now audit a minimum of 10% of all renewals. Only if you are audited will you be required to submit certificates. You will be notified if you are audited in your emailed renewal reminder that is sent approximately 90 days prior to your renewal date.
